Was promoted to H.P. higher judicial service on January 2013 and remained posted as presiding officer (Addl. District & Sessions Judge) Fast Track Court Shimla upto 30.04.2013. Was inducted as Additional District & Sessions Judge on adhoc Basis from 31-04-2013 and was inducted in regular cadre of Additional District and Sessions judge from November 2013. On transfer, joined as Additional District & Sessions Judge Ghumarwin w.e.f 20-05-2013. Thereafter, promoted as District & Sessions Judge and joined at Civil & Sessions Division Kinnaur at Rampur Bushahr on 12.05.2016. Transferred from Rampur Bushahr on 26-10-2016 and joined as such in Civil & Sessions Division Chamba on 12.11.2016. On transfer, joined as Presiding Officer, Labour Court-cum-Industrial Tribunal on 28.12.2018. Thereafter, joined as Chairman, District Legal Services Authority, Kangra at Dharamshala on 09.08.2021.
